

The Münster Colloquia

The Münster Colloquia deal with the adaptation of EU law as a reaction to the transition to the digital economy. They bring together renowned lawyers from academia and legal practice as well as EU/national policy makers and stakeholder representatives. They are a privileged forum to discuss the concepts and instruments which respond to the needs of the digital economy, for instance the emerging private law of the data economy.

The subject of the 8th Münster Colloquium is the Data Act, the Regulation on harmonised rules on fair access to and use of data. The colloquium will look in-depth at the private law part of the Data Act. The Data Act is a major milestone in the emerging law of the data economy. It regulates the conditions under which value can be created from data. Its contract law related parts grant data access rights, regulate their contractual modalities, monitor unfair contract terms and regulate cloud computing contracts. These parts constitute major deliverables on the way to adapt private law to the emerging role of data as the new production factor and the needs of the data economy. As one of the, if not the first expert event on this subject, the Münster Colloquium will discuss three key aspects: mandatory data sharing in the triangle "data-holder - user - data-recipient", voluntary data sharing on a bilateral basis and cloud-contracts.
